Constructing Relative Clauses

is standing over there is my friend.
is on the bestseller list is very popular.
is located on the coast is a popular tourist destination.

Example Sentences:

- The person who is standing over there is my friend.
- The book that is on the bestseller list is very popular.
- The city which is located on the coast is a popular tourist destination.

Relative Clauses in Context



"The city, which is located on the coast, is a popular tourist destination. The hotel, where we stayed, was very comfortable. The staff, who were very friendly, made our stay very enjoyable."

Restrictive and Non-Restrictive Relative Clauses

Definition: Restrictive relative clauses provide essential information about the person, place, or thing, while non-restrictive relative clauses provide additional information that is not essential.

Example: "The book that is on the table is mine." (Restrictive) vs. "The city, which is located on the coast, is a popular tourist destination." (Non-Restrictive)
